# **Reffer.ai Terms of Service**

# 1. Introduction

Welcome to reffer.ai ("**Service**"), a platform dedicated to providing users with the ability to register, purchase packages using USDT, receive vouchers for hyperhub.ai services, and participate in our AI training program. This Terms of Service Agreement ("**Agreement**") is a contract between you ("**you**," "**your**") and reffer.ai ("**we**," "**our**," "**us**") and governs your access to and use of the reffer.ai website and all associated services (collectively, "**Services**").

• We do not engage in investment activities or operate as an investment organization in any capacity. Reffer.ai is not an investment company and does not guarantee earnings or income from purchasing our packages or participating in any company activities.

- Packages and USDT Transactions: Users can purchase packages with specified benefits, including vouchers for services at hyperhub.ai. All purchases are made using USDT and are subject to the terms and conditions of the transaction.
- Refunds and Cancellations: All transactions made through our Service are considered final and non-refundable, except as required by law or as otherwise stated in the terms of a specific service. Notwithstanding the foregoing, users have the right to cancel their purchase within 14 days of the transaction date. If a cancellation is made within this period, the user will receive a full refund of the purchase price. This cooling-off period is designed to ensure that you have ample time to reconsider your purchase decision.
